



Work Safety Alert Fallen from Tail Lift of a Truck

1. **Date of Accident :** April 2024
2. **Place of Accident :** A warehouse
3. **Summary :**

While a male worker was pulling out a pallet of goods from the compartment of a truck to its tail lift, he fell from the tail lift to the ground. He sustained serious head injuries and passed away three days later.

4. **Work Safety Alert for Truck Owners/ Employers :**

To prevent workers / employees engaged in loading/ unloading/ handling of goods on a truck from falling from height, the truck owners/ employers should provide and maintain a safe system of work which may include, but not limited to, the following:

- appointing a competent person to conduct a task-specific risk assessments to identify all potential hazards associated with the loading/ unloading/ handling of goods, taking into account the nature of work and the working environment, particularly those places where workers/ employees are liable to fall from height;
- formulating safe work methods and procedures for the loading/ unloading/ handling of goods with due regard to the results of the risk assessments, the size and shape of the goods and the working environment;
- providing suitable and adequate safe means of access to and egress from any place of work on the truck and ensuring the proper use of the access and egress by workers/ employees;
- ensuring that adequate safety precautions have been taken to prevent



workers/ employees from falling from height, such as providing each worker/ employee with and ensuring the use of an effective fall protective system;

- affixing prominent warning tape at appropriate positions to alert workers/ employees of the falling hazards;
- providing all workers/ employees concerned with the necessary safety information, instruction and training, and ensuring that they are familiar with the safe work procedures and safety measures; and
- establishing and implementing an effective monitoring and control system to ensure all safety measures are strictly followed.
