



Work Safety Alert

Fall from a Canopy

1. Date of Accident: Nov 2015

2. Place of Accident: Outside a retail shop

3. Summary:

A worker fell about 5 metres to death from a canopy to the ground while dismantling a signboard of a ground floor retail shop at the external wall of the building.

4. Work Safety Alert for Proprietors/ Employers:

To prevent any person from falling from height, the proprietor/ employer engaged in dismantling work at external walls should provide and maintain a safe system of work which should include, but not limited to, the following:

- appointing a competent person to conduct task-specific risk assessments taking into account the nature of the work and the working environment;
- formulating safe work methods and procedures for the dismantling work with due regard to the results of risk assessments;
- strictly prohibiting access to or working on unprotected canopy or other unsafe places;
- providing and properly maintaining suitable and adequate safe means of access to and egress from every place of work;
- providing and ensuring the use of suitable working platforms or elevating work platforms where practicable for the dismantling work and refraining from using ladders as far as reasonably practicable;





- where use of working platforms/ elevating working platforms is impracticable, providing and ensuring the proper use of suitable fall arresting system by workers;
- properly suspending/ supporting the object to be dismantled, e.g. by using a suitable lifting appliance and lifting gears, to prevent its undue movement during dismantling;
- if a lifting appliance is used, ensuring that it is only operated by a person who is trained and competent to operate it and holds a valid certificate if applicable;
- appointing a competent person to be in charge of the lifting appliance when the object to be dismantled is being left suspended from it;
- ensuring that every lifting appliance and lifting gear is tested, thorough examined and certified safe by a competent examiner before it is used;
- providing all workers involved with necessary safety information, instruction and training to ensure that they are familiar with the safe work procedures and safety measures; and
- establishing and implementing an effective monitoring and control system to ensure strict and full compliance with all the above safety measures.
