



Work Safety Alert

Fall through a Window Opening

- 1. Date of Accident : February 2016
- 2. Place of Accident : A residential building

3. Summary :

A worker fell to death through a window opening of an upper floor unit on 17/F of a residential building to the 2/F flat roof while cleaning the window.

4. Work Safety Alert for Contractors/ Employers :

To prevent any workers/employees from falling from height through window openings, the contractors/employers engaged in any work at or near window openings should:

- appoint a competent person to conduct task-specific risk assessments to identify all associated potential hazards, taking into account the nature of work and the working environment;
- formulate safe work methods and procedures with due regard to the results of risk assessments;
- adopt safe work methods and avoid over-stretching the body beyond the window openings or working above ground near the window openings by using suitable equipment or tools;
- where work-above-ground near the window openings cannot be avoided, ensure suitable working platforms with proper guard-rails and toe-boards, such as step platforms, be provided and used for the work;
- where workers/employees engaged in work at or near window openings are exposed to falling hazard, provide each of them with a suitable safety





harness that is continuously attached to a suitable and secure anchor point, an independent lifeline or a fall arresting system from a safe place; and ensure the proper use of them by the workers/employees throughout the work;

- display warning notices at prominent places near window openings to alert workers/employees to the falling hazard;
- provide all workers/employees who are engaged in work at or near window openings with necessary safety information, instruction and training;
- ensure that workers/employees concerned are working in accordance with the safe work methods and procedures with all necessary safety measures adopted; and
- establish and implement an effective monitoring and control system to ensure strict and full compliance with all the above safety measures by the workers/employees.
