



Work Safety Alert

Falling into Sea from a Sea Viaduct under Construction

1. Date of Accident : April 2016

2. Place of Accident: A sea viaduct under construction

3. Summary:

A worker, while working on a sea viaduct under construction, fell about 15 metres to death into the sea.

4. Work Safety Alert for Contractors/ Employers:

To prevent any persons from falling into water from height, the contractor/ employer responsible for any construction work over/ near water should:

- appoint a competent person to conduct task-specific risk assessments in identifying all potential hazards associated with the construction work, taking into account the nature of work and the working environment;
- formulate safe work methods and procedures with due regard to the results of the risk assessments;
- erect effective guard-rails and toe-boards at all edges of the workplaces where persons are liable to fall from height or into water; and ensure that the guard-rails are of adequate strength and securely fixed;
- ensure that the height of a guard-rail above the surface of the edge is not less than 900 millimetres and not more than 1150 millimetres for a top guard-rail and not less than 450 millimetres and not more than 600 millimetres for an intermediate guard-rail; and that the height of a toe-board is not less than 200 millimetres;





- if erection of guard-rails at dangerous edges is impracticable or temporary removal of the guard-rails is unavoidable, provide every worker/ employee who is engaged in the work near the edge with a suitable safety harness that is continuously attached to a suitable and secure anchor point, an independent lifeline or a fall arresting system from a safe place; and ensure the proper use of them by the worker/ employee throughout the work in the vicinity of the edges;
- ensure that every worker/ employee at the workplace who is at risk of falling into water, is wearing a lifejacket; and the lifejackets so provided should fit the wearers and should not affect their vision, hearing or breathing, nor contain any component which may cause injury to the wearers in normal use;
- formulate effective rescue procedures to deal with emergency situations;
- provide suitable rescue equipment against drowning and keep it readily accessible for emergency use; and take measures to arrange for the prompt rescue of any person in danger of drowning;
- make available sufficient first aid equipment including stretcher(s), sucker for clearing a person's airway, portable resuscitation equipment and first aid facilities for immediate use in case of emergency;
- provide all workers/ employees and other relevant site personnel with necessary safety information, instruction and training and ensure that they are familiar with the safe work procedures, safety measures and emergency arrangements in preventing fall into water; and
- establish and implement an effective monitoring and control system to ensure strict and full compliance with all the above safety measures.
