



# Work Safety Alert Struck by a Moving Vehicle

1. Date of Accident: June 2016

**2.** Place of Accident: Area near a toll plaza on a link road

## 3. Summary:

A traffic controller while directing traffic in the control area near a toll plaza on a link road was knocked down by a moving vehicle. As a result, he sustained serious injuries and subsequently died.

### 4. Work Safety Alert for Contractors/ Employers:

To prevent any workers/ employees working in the above area or similar workplaces from being endangered by moving vehicles, contractors/ employers should provide and maintain a safe system of work which should include, but not limited to, the following:

- appointing a competent person to conduct task-specific risk assessments in identifying all potential hazards including those related to road traffic and emergency situations, taking into account the nature of work, flow of traffic and movement of workers to-and-fro the work area;
- formulating safe work methods and procedures prior to the work with due regard to the results of risk assessments, and in line with relevant codes of practice and guidelines;
- demarcating and isolating the work area by suitable warning lights, traffic signs and barriers after closing the respective traffic lane(s) in line with established safety procedures;





- ensuring that the setting up procedures and requirements of warning lights, traffic signs and barriers are in accordance with the relevant codes of practice;
- ensuring that the barriers provided are capable of absorbing the energy of colliding vehicle in order to minimize damage and injuries to workers/ employees concerned;
- as far as practicable, giving advance warnings to alert road users about any emergency situations such as road accidents ahead through the display/ broadcasting systems of the highways/ tunnels;
- using flashing arrow signs with barricade signs to indicate beginning of temporary traffic diversion;
- where appropriate, imposing speed limits on traffic routes through erecting speed limit signs;
- placing plant, equipment and tools as far away as practicable from the moving vehicles;
- maintaining adequate buffer distance from the barriers to the work area;
- arranging the operation to be performed with the workers/ employees concerned facing oncoming traffic as far as possible;
- arranging the workers/ employees who guide vehicles to carry out their duties as far as possible safe by position and providing them with personal protective equipment as necessary such as high visibility or reflective vest and ensuring their proper use of the equipment;
- providing all workers/ employees with adequate information, instruction and training and ensuring that they are conversant with the safe work procedures and safety measures; and





• developing and implementing an effective monitoring and control system to ensure that the above safety measures are strictly followed.
