



Work Safety Alert Trapped by an Overturned Fork-lift Truck

1. Date of Accident: November 2016

2. Place of Accident: The loading bay of a warehouse

3. Summary:

A fork-lift truck overturned during operation and trapped the operator to death.

4. Work Safety Alert for Proprietors/ Employers:

To ensure the safety of workers/ employees engaged in goods handling work by means of fork-lift truck, the proprietors/ employers should provide and maintain a safe system of work which should include, but not limited to, the following:

- appointing a competent person to conduct task-specific risk assessments in identifying all potential hazards associated with the operation of fork-lift truck, taking into account the working environment, travelling routes and the limitations of the fork-lift truck as specified by the manufacturer's instructions;
- formulating safe work methods and procedures for the goods handling work by means of fork-lift truck with due regard to the results of risk assessments;
- as far as possible, providing suitable barriers at the edges of loading bays and clearly marking these areas, such as by black and yellow stripes, to improve their visibility;





- ensuring that the travelling routes of the fork-lift truck are properly planned to avoid sharp turns as far as possible;
- imposing speed limits to fork-lift trucks which should be clearly set and signposted on travelling routes and taking effective steps to prohibit overspeeding particularly when making turns;
- providing an operator restraint system or a suitable seat belt to the fork lift truck;
- where a seat belt is provided, ensuring that the operator is using the seat belt properly while operating the fork-lift truck;
- conducting examinations and inspections to the fork-lift truck regularly to ensure that it is in safe working order;
- developing and maintaining an effective preventive maintenance programme to ensure that all safety devices of the fork-lift truck are maintained in an efficient state and are functioning properly at all times;
- ensuring that the fork-lift truck is operated by a person who is competent and is holding a valid certificate relevant to the type of fork-lift truck;
- providing necessary safety information, instruction and training to all workers/ employees concerned and ensuring that they are familiar with the safe work procedures and safety measures; and
- establishing and implementing an effective monitoring and control system to ensure the above safety measures are strictly followed.
