

The Arrangement

Working Holiday Working Permit The Working Holiday Arrangement between Canada and Hong Kong takes effect on 1 March 2010. The Arrangement allows young people from Canada and Hong Kong to travel and work in the other territory, for up to one year. This provides an opportunity for Canadian and Hong Kong youth to broaden their horizons and gain first-hand living experience in a foreign culture, while allowing them to supplement their funds through incidental employment.

Successful Hong Kong applicants will be issued a Letter of Introduction, which can be exchanged for a work permit at the port of entry in Canada. During their stay, working holidaymakers can take up employment while in Canada in order to supplement their travel funds. There are currently 200 places per year under this Scheme. Qualified applications will be approved on a first-come, first-served basis.

Eligibility

To be eligible for the program, Hong Kong applicants wishing to travel to and work in Canada must:

- > be ordinarily resident in the HKSAR, holding a valid HKSAR or BNO passport;
- > comply with all relevant immigration legislation and regulations, including admissibility;
- > be aged between 18 and 30 and not be accompanied by dependent family members under this application;
- > possess a return travel ticket or sufficient funds with which to purchase such a ticket, and have proof that they possess the financial resources necessary to provide for their needs during the period of initial stay in Canada (CDN\$2,500);
- > pay the applicable fee (in HKD equivalent of CDN\$150);
- > purchase insurance for medical and health care for the entire duration of the stay; and
- > confirm that their intention is to improve their knowledge of the languages, culture and society of Canada.
