<sup>1</sup> According to section 45(2) of the Trade Unions Ordinance, a registered trade union must, within 1 month after becoming a member of an organization which is established in a foreign country as provided in section 45(1)(a), notify the Registrar of Trade Unions in writing of the fact.

<sup>2</sup> According to section 44A of the Trade Unions Ordinance, “relevant professional organization”, in relation to a registered trade union, means an organization the objects of which are to promote the interests of persons engaged or employed in a trade, industry or occupation that is the same as, or similar to, the trade, industry or occupation with which the trade union is directly concerned.
