



Work Safety Alert **Pressed by Demolition Debris**

- 1. Date of Accident :** November 2023
- 2. Place of Accident :** A village house under demolition
- 3. Summary :**

While a worker was conducting demolition work on 1/F of a village house, the floor slab of 1/F suddenly collapsed. He fell onto G/F and was pressed by some demolition debris. He was sent to hospital and passed away the next day.

4. Work Safety Alert for Contractors/ Employers :

To ensure the occupational safety of workers engaged in demolition work, the contractors/ employers responsible for the work should provide and maintain safe systems of work which should include, but not limited to, the following:

- appointing a competent person to conduct task-specific risk assessments to identify all potential hazards associated with the demolition work, taking into account the nature of work, the demolition methods and sequence, the construction and stability of the structures to be demolished, the working environment, etc.;
- formulating safe work methods and procedures for the demolition work with due regard to the results of risk assessments, the requirements of safety legislation, codes of practice and safety guidelines;
- providing substantive support to the structures to be demolished as necessary to prevent any part of the structures from accidental detachment, collapse, toppling or failure;



- ensuring the work is carried out by workmen with adequate training and experience under the immediate supervision of a competent person who should have sufficient technical knowledge and able to read and understand drawings, risk assessment reports and method statements of the work;
- providing all workers concerned with the necessary safety information, instruction and training, and ensuring they are familiar with working environment, safe work methods/ procedures and safety measures; and
- establishing and implementing an effective monitoring and control system to ensure all safety measures are strictly followed.
