



Work Safety Alert

Struck to Death by a Bundle of Timbers

1. Date of Accident : March 2024

2. Place of Accident : A warehouse

3. Summary :

A worker was struck to death when a bundle of timbers fell from the trailer of a truck during an unloading operation.

4. Work Safety Alert for Proprietors/ Employers :

To ensure the safety of workers engaged in loading/ unloading operation, the proprietors/ employers should provide and maintain a safe system of work which may include, but not limited to, the following:

- appointing a competent person to conduct task-specific risk assessments to identify all potential hazards associated with loading/ unloading operation, taking into account the size, shape, weight, centre of gravity, packing arrangement of loads and the work environment, with particular attention paid to any movement/ displacement of the loads to be handled and loads nearby;
- formulating safe work methods and procedures for loading/ unloading operation with due regard to the results of risk assessments, and following the requirements of relevant safety legislation and guidelines to minimise the risks of workers;
- stacking, stabilizing and handling the loads properly, particularly loose loads packed in bundles, to prevent them from displacement in the course of loading/ unloading operation;
- appointing a competent supervisor to oversee the loading/ unloading operation including assessing the number of lashings to be removed at a



time, taking into account the integrity and stability of the loads and loads nearby;

- ensuring that the machinery used for loading/ unloading operation is only operated by an authorised person who has adequately trained and is competent by reasons of substantial training and practical experience;
- demarcating and properly barricading a zone for loading/ unloading operation and practicing strict access control measures with suitable warning notices posted in the vicinity to prohibit unauthorised entry into the zone when loading/ unloading operation is in progress;
- providing all workers concerned with necessary safety information, instruction and training, and ensuring that they are familiar with the safe work procedures and relevant safety measures; and
- establishing and implementing an effective monitoring and control system to ensure all safety measures are strictly followed.
