The primary objective of the legislation related safety and health training courses (including Trainer Courses, Briefing Sessions and Occupational Health Talks) offered by the Occupational Safety and Health Training Centre of the Labour Department aims at enabling course participants to understand the statutory requirements, compliance standards and other legislation-related issues.
- 2. The Trainer Courses aim at training the trainers or those who are required to perform regular training duties in legislation related matters. After attending the courses, they are expected to assist their employers in organising in-house training in their own organisations. The Briefing Sessions and Occupational Health Talks are designed for those who are required to perform regular briefing duties on safety and health legislation.
